#### New Business -

Pasture Budget Group has some very positive feedback from all parties involved.

Tom – Lovegrass - Lovegrass on roadways in the borombola area is becoming a concern, many local farmers are taking it on themselves to control their patch of road rather than waiting on the LLS or shire to do so. There needs to be a follow up with Matt Mcgrath on the lovegrass issue.

All present – Noxious weeds - The discussion was had there needs to be better enforcement of weed control on properties (by the LLS or local weed inspectors) on landholders which are doing nothing about their weed issues and their neighbours are. John commented that the state of many properties coming down the valley is disgusting with summer weeds taking hold being either burrs, blackberries or more lately Noogoora burr. These landholders who have these weeds and are doing nothing about it need to be made accountable of their lack of weed control and dealt with more seriously by the LLS or Weed inspectors.

### Borombola - has gone quite on carp-a-thon - Maybe October?

Julia – completed a grant writing school (said it was riveting!) and that local regional development board can check individual grants if needed.
